

STEP 1 - Unpacking the CarryOn.

After unpacking, unlock the perspex door using the supplied keys




Remove the plastic divider by lifting the base tabs first then lift the divider and gently pull forward.



STEP 2 - Routing the device cables in the CarryOn.

Undo the four screws that secure the device shelf.



Remove the device shelf, flip over and plug in the USB-A plugs of the device cables into the USB charger.




NOTE: Use the green velcro cable ties supplied to neaten the cables if using long cables.

Route the cables through the 'strain relief device' as shown, allowing the correct length for your device.




Route the cables through the 'tear-drop' slots.




Picture above: Completed cable installation.

CarryOn

Replace the device shelf into the CarryOn and tighten the four fixing screws.



Replace the plastic divider.
Insert the rear tabs first.



STEP 3 - Connecting the devices and powering on the CarryOn.

Insert the devices and connect the charging cables.



Plug in the power cord, connect to a wall outlet and switch it on. Charging will automatically start.



STEP 4 - Locking and storing.

Lock the door when unattended and when transporting the devices (to prevent accidental dropping).



When not in use, wrap power cable around cleats.



Additional Step - Mounting the wall hanging bracket for the CarryOn.


NOTE: mount the wall bracket in a location where there is no personnel traffic as the protruding arms may cause a hazard when the CarryOn is not engaged.

Only a suitably qualified person should install the wall mounting bracket to a wall of suitable material (masonry, concrete, timber stud etc.) using fixings that can hold up to 10kg (22 lb).

Insert bracket 'arms' into the disc and hold against the wall in the chosen location, ensuring the bracket is level. Then mark the four (4) holes.



Drill holes and insert four screws and tighten.




Place the CarryOn onto the wall bracket.



Use a 25 mm (1") padlock to secure*.



** PLEASE NOTE: only a 25mm (1") padlock will fit.*



Lock dimensions (maximum):

- a: any size
- b: 15 mm (0.591 inch)
- c: 19 mm (0.748 inch)
- d: 5 mm (0.197 inch)
